T2.3 Secondments and good practices exchange

The aim of Task T2.3 is to facilitate the exchange of expertise between IFIGENEIA's partners and the research, academic, business, and NGO stakeholders of each Hub, with the goal of bridging existing gaps.

This task involves the preparation of a comprehensive secondment proposal, detailing key parameters such as participants, locations, duration, and implementation timeline, along with all relevant logistical arrangements.

The primary objective is to foster mutual understanding and capability-building across sectors—specifically between academia, NGOs, and industry, through targeted knowledge exchange.

Potential hosting entities include:

- Accelerator Technology Sector (CERN)
- Knowledge Transfer Offices (e.g., Slovenia, GSI)
- Expert Centres (e.g., medical or technical institutions such as DKFZ)

Secondments are bidirectional and may also include hosting at CERN and DKFZ, ensuring a rich, cross-sectoral learning environment.

It is anticipated that two staff members per year will participate in secondments lasting 2 to 4 weeks, gaining handson experience in diverse operational settings.
